Update 15: California, United States of America - More Counties Announce New Restrictions Amid Rise in COVID-19 Cases

- On Monday, November 30th, Counties across California will begin stricter COVID-19 restrictions as cases surge statewide and Thanksgiving travelers return home
- Health officials are preparing for a wave of COVID-19 cases in the next two or three weeks that could be tied to Thanksgiving gatherings
- Authorities had urged residents to stay home and keep their interactions with others limited, yet millions nationwide defied that advice
- As of Sunday, November 29th, California has had nearly 1.2 million confirmed COVID-19 cases since the pandemic began
- The state reported around 15,600 new cases on Saturday, November 28 th
- There have been 19,121 virus-related deaths in California during the pandemic
- The figures are expected to rise in the coming days
- Los Angeles County has ordered citizens to stay at home and banned public and private gatherings until at least December 20 th, except for faith-based services and protests
- Santa Clara County is banning all high school, collegiate and professional sports and imposing a quarantine for those traveling into the region from more than 150 miles (241 kilometers) away
- San Francisco and San Mateo counties moved to the most restrictive purple tier in the state's pandemic blueprint for the economy, forcing most indoor activities to close by noon Sunday, November 29th
- As of now, the United States of America reported 13,750,404 confirmed COVID-19 cases with 273,072 deaths (2.0% of total reported cases), and 8,107,203 recovered (59.0% of the total reported cases)

Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
