# Update 31: United States of America - Multiple States Start Easing COVID-19 Restrictions Despite Warnings

- Texas will lift its mask mandate and increase the capacity of all businesses to 100% from March 10, 2021, Governor Greg Abbott
  has announced
- The announcement by the Republican leader in Texas, where the virus has killed more than 42,000 people, has rattled doctors
  and city leaders who said they are now bracing for another deadly resurgence
- The Centers for Disease Control and Prevention (CDC) warned of a potential resurgence of COVID-19 infections in the US, despite a dip in the numbers of new cases nationally
- Mississippi, Louisiana, and Michigan, as well as Chicago and San Francisco, all made announcements to ease restrictions on March 02, 2021, though the details varied
- Montana, Iowa, North Dakota, and Mississippi have already waived mask-wearing restrictions, and Michigan has eased other lockdown restrictions
- Florida, Georgia, and South Carolina have not enforced state-wide mask mandates throughout the pandemic
- In Florida and South Dakota, schools and businesses have been wide open for months
- More than 35 US states have kept their mask-wearing rules in place, albeit with variable enforcement
- In the US, cases have decreased more than 70% over the past two months from an average of nearly 250,000 new infections a day, while average deaths per day are down about 40% since mid-January 2021
- But the two curves have leveled off abruptly in the past several days and have even risen slightly, and the numbers are still running at alarmingly high levels with an average of about 2,000 deaths and 68,000 cases per day
- Health officials are increasingly worried about virus mutations
- On the positive side, in the US, more Americans have now received at least one dose than have tested positive for the virus since the pandemic began
- So far, 80.5 million doses have been given
- In the last week, an average of 2.01 million doses per day was administered
- As of now, the country has reported 29,456,377 confirmed COVID-19 cases with 531,652 deaths, 1.80% of the total reported cases, and 20,003,325 recoveries, 67.91% of the total reported cases
- When compared to the overall population of the country, confirmed COVID-19 cases and fatality rate stands at 8.86% and 0.16%, respectively

# Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
