Update 33: Romania - Anti-Vaccination Protest Witnessed Across the Country as Authorities Announce New Restrictions Amid Increase in COVID-19 Cases

- Around 3,000 anti-vaccination protesters from across Romania converged outside the parliament building in Bucharest on March 7, 2021, as authorities announced new restrictions amid a rise of COVID-19 infections
- It has been less than six weeks since COVID-19 restrictions were relaxed in Bucharest, but rising infections have prompted authorities to reimpose tighter restrictions for a 14-day period effective March 8, 2021
- Many protestors brandished Romanian flags and chanted 'freedom' and 'down with the mask' a large placard read: 'Say no to forced vaccination'
- The restrictions will see bars, restaurants, theatres, gambling venues, and cafes close indoor spaces as the capital's infection rate rose above three cases per 1,000 inhabitants over a 14-day rolling period which the authorities use as a threshold to manage both restrictions and the spread of the virus
- Also, the new restrictions will see many schools in the capital revert back to online learning, while nurseries, primary school
 pupils, and those from eighth to 12th grades will continue with physical attendance, in some cases operating only at half capacity
- Harsher measures are to be imposed at the same time in the western city of Timisoara, a city of more than 400,000 residents, which will enter quarantine after its infection rate rose above seven per 1,000 residents
- In guarantined areas, inhabitants are obliged to fill out an official form stating the reason for their movement
- Across the country, there is an enforced curfew between 11 pm 6 am
- According to a government website, more than 1.7 million people in Romania have received a COVID-19 vaccine
- As of now, Romania reported 828,283 confirmed COVID-19 cases with 20,900 deaths ~2.5% of total reported cases and 754,335 recoveries, ~91.1% of total reported cases
- When compared to the overall population of the country, confirmed COVID-19 cases and fatality rate stands at 4.3% and 0.1%, respectively

Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
