Update 20: Estonia - Extends Requirement of Quarantine and Negative Test Results for All Travellers Until April 18, 2021

- Estonia has announced that all persons entering the country from a European Union (EU) country placed on the high-risk COVID-19 list during the period April 12, 2021 - April 18, 2021, are required to undergo testing and remain self-isolated for ten days
- The new restrictions say that persons entering from an EU country with an infection rate higher than 150 can perform essential duties if they are able to present a negative COVID-19 test result carried out not any longer than 72 hours before
- The test can also be taken after entering Estonia
- · However, in such cases, all persons must remain in self-isolation until the test results are received
- Furthermore, everyone is allowed to return to their country as long as they submit a negative test result not older than 72 hours before leaving Estonia
- The Ministry further pointed out that the same rules apply to the Estonian residents as well who work in a neighboring country that is part of the EU
- However, persons who have been COVID-19 positive and have been declared healthy six months before entering Estonia or those who have been vaccinated against the COVID-19 are not required to undergo testing or any self-isolation measures
- The Ministry suggests that everyone needs to assess the necessity of their trip, as due to the unexpected introduction of new measures traveling requirements to and from Estonia may change at any time
- As of now, the country has reported 115,080 confirmed COVID-19 cases with 1,049 deaths, ~0.9% of the total reported cases and 96,844 recoveries, ~84.1% of total reported cases
- When compared to the overall population of the country, confirmed COVID-19 cases and fatality rate stands at ~8.7% and ~0.1%, respectively
- In total, 333,835 vaccine doses have been given and 74,774 people, ~5.6% of the total population have been fully vaccinated against COVID-19

Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
