Update1: Peru - Extends Suspension of Flights from Brazil, United Kingdom and South Africa to Curb the Spread of COVID-19

- Peru will stop commercial flights with Brazil, the United Kingdom and South Africa at least until mid-May 2021
- This measure was put in place after the government extended the suspension for another two weeks in an effort to stem the spread of COVID-19
- It was placed by the Ministry of Transport and Communications (MTC) through a ministerial decision
- The standard extends from May 1 to 15, 2021, to suspend passenger flights from the three countries where outbreaks of new variants of the COVID-19 have been recorded, as a preventive measure to reduce the risk of infection
- Commercial flights with the United Kingdom have been suspended for nearly a year, having been in operation for only a week since the government issued its first mandatory national quarantine on March 15, 2020
- After a short opening, in December 2021, the Peruvian government again suspended its contacts with Europe, when the
 expansion of the British variant of the COVID-19 was confirmed
- Peru currently has open borders with some European countries, including Spain (Madrid and Barcelona), the Netherlands (Amsterdam) and France (Paris)
- However, it remains closed to travellers from the United Kingdom
- To enter the territory of Peru, health authorities require a negative PCR (Polymerase Chain Reaction) for COVID-19
- The test has to be performed 72 hours in advance, as well as a medical certificate and permanent use of a mask and face shield is required throughout the flight
- Reported COVID-19 stats for Peru:
 - 1. Confirmed Cases 1.818.689
 - 2. Deaths: 62,674 (3.4%)
 - 3. Recoveries: 1,688,091 (92.8%)
 - 4. Vaccine Doses Administered: 1,430,411
 - Fully Vaccinated: 447,000 (2%)

Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
