

Update 9: Argentina - Suspends and Reduces Flights to Africa and Europe Until June 25, 2021 Amid COVID-19 Pandemic

- On June 15, 2021, Argentina's government suspended and reduced several flights to and from destinations such as Turkey and countries on the African continent
- The country also announced to continue with the policy of minimum frequencies on flights to Europe
- This comes into effect to prevent the arrival in Argentina of new strains of COVID-19 circulating in other countries
- The main concern being the Beta variants originating in South Africa and Delta variants in India
- The decisions related to permits to air transport operations of passengers on direct flights to and from Great Britain and Northern Ireland, Turkey, and other countries of the African continent will be extended until June 25, 2021
- To this list are added those originating in Brazil, Chile or India, due to the new COVID-19 strain
- The government recalled that the entry of foreigners into the national territory is prohibited
- The exception being in cases specifically authorized by the National Direction of Migration for reasons such as family reunification, health or humanitarian reasons
- Likewise, the only access routes are Ezeiza Airport, San Fernando Airport, Jorge Newbery Airport, and the Buquebus terminal at the port of Buenos Aires, since the land borders are closed
- To enter the country, all citizens must complete an electronic affidavit 48 hours prior to boarding and have a total of three tests for SARS-CoV-2
- The first one is prior to entry, then a new test will be performed and another one after seven days
- Authorized foreign nationals must also attach COVID-19 medical insurance
- Reported COVID-19 stats for Argentina:
 1. Confirmed Cases: 4,172,742
 2. Deaths: 86,615 (2.08%)
 3. Recoveries: 3,771,968 (90.40%)
 4. Vaccine Doses Administered: 16,643,769
 5. People Fully Vaccinated: 3,420,581 (7.6%)

Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
