# Update 38: Ho Chi Minh City, Vietnam - Imposes Night Curfew Effective July 26, 2021 Amid Surge in COVID-19 Cases

- Vietnam's economic hub, Ho Chi Minh City has imposed a strict night curfew due to surge in COVID-19 cases
- The curfew will be effective from July 26, 2021, until further notice
- The new restrictions will include:
  - All citizens are directed to stay indoors from 6 pm (VNM) to 6 am (VNM)
  - Residents are advised to step out from home only to avail essential services such as medical and food
  - Almost all public transport connections to the city were suspended
  - Travelers originating from the city are required to stay in mandatory quarantine centers for at least two weeks
- Earlier, the city had suspended all outdoor activities and ordered non-essential businesses to close following an increase in cases
- · Only government offices, hospitals and essential businesses are allowed to stay open
- The government also banned the gathering of more than two people in public places
- On July 27, 2021, Vietnam has reported 2,708 new COVID-19 cases, of which 4 were imported and 2,704 were recorded domestically in Ho Chi Minh City
- The main affected areas in the country are industrial towns in the North and Ho Chi Minh City in the South
- Currently, more than a third of Vietnam's 100 million people are under a lockdown, including residents of its capital Hanoi in the North
- Vietnam has also been slow to vaccinate, with only approximately 4.7 million doses administered so far
- Reported COVID-19 stats for Vietnam:
  - 1. Confirmed Cases: 109.111
  - 2. Deaths: 524 (0.48%)
  - 3. Recoveries: 21,344 (19.56%)
  - 4. Vaccine Doses Administered: 4,613,491
  - 5. Fully Vaccinated Population: 389,863 (0.41%)

# Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
