

Update 88: United Kingdom - Eases Entry Restrictions for Vaccinated Travellers from European Union and US

- People who were fully vaccinated in the EU or US will not need to isolate when coming to England, Scotland, and Wales from an amber list country
- The change will come into force on August 02, 2021, at 04:00 am BST
- Currently, only people who received their jabs in the UK can avoid quarantine when arriving from amber list countries, except France
- The UK government said the rule change would help to reunite family and friends whose loved ones live abroad
- It would apply to people who have been fully vaccinated with a jab approved by the EU or US, with the final dose at least 14 whole days before arrival
- Travellers will still need to take either a lateral flow or PCR test pre-departure and a PCR test on the second day after they arrive
- Under-18s will be exempt from isolation, and some will not have to test, depending on their age
- On July 28, 2021, a further 27,734 cases were reported in the UK, bringing to an end a seven-day run of falling case numbers
- The daily COVID-19 case figure was, however, down significantly from a week ago, when 44,104 cases were reported
- Another 91 deaths within 28 days of a positive test were also reported
- Tougher rules will continue to be in place for France, which is on the amber list but still requires travellers to quarantine when they return, even if they are fully vaccinated
- As part of the changes, international cruise ships will be able to depart from England from August 02, 2021, after a 16-month pause
- Reported COVID-19 stats for the UK:
 1. Confirmed Cases: 5,770,928
 2. Deaths: 129,430 (2.24%)
 3. Recoveries: 4,480,533 (77.64%)
 4. Vaccine Doses Administered: 83,239,491
 5. Fully Vaccinated: 55.3% of the population

Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
