

Update 64: Canada - Issues Guidelines for Easing Border Restrictions with United States Effective August 9, 2021

- Canada issued guidelines for easing COVID-19 restrictions for fully vaccinated US citizens and US permanent residents for non-essential travel effective August 9, 2021
- Earlier, the United States had extended its land border travel restrictions on the northern and southern borders until August 21, 2021
- US citizens and permanent residents who are residing in the United States (who are not otherwise exempt from the travel restrictions) will be able to enter Canada at land borders for discretionary travel, tourism, with proof of vaccination in English or French
- Travel requirements include the following:
 1. Translations of proof of vaccination will be accepted if accompanied by the original vaccination certificates
 2. Travelers should use ArriveCAN to submit travel information, including proof of vaccination
 3. Vaccinations must be from vendors accepted by the Canadian government
 4. Unvaccinated children under 12 years of age will be able to enter Canada if they are traveling with a parent or guardian who is fully vaccinated
 5. Those who cannot receive the vaccinations for health reasons will be able to enter Canada and the Canadian government soon will be providing more details on required proofs
 6. Pre-entry COVID-19 molecular tests will still be required even for fully vaccinated travelers
 7. Quarantines will be required only for individuals who show COVID-19 symptoms
 8. All visitors must adhere to Canada's COVID-19 health measures, including masking in public places, carrying vaccination proof, and monitoring themselves for COVID-19 symptoms
- Additionally, Canada's annual inflation rate in June 2021 dipped to 3.1% from a YoY increase of 3.6% in May 2021 as food, transport and clothing costs eased
- Reported COVID-19 stats for Canada:
 1. Confirmed Cases: 1,428,683
 2. Deaths: 26,570 (1.86%)
 3. Recoveries: 1,396,646 (97.76)
 4. Vaccine Doses Administered: 48,255,004
 5. Fully Vaccinated: 21,415,908 (56.4%)

Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
