

Update 45: Estonia - Imposes Travel Restrictions on 13 European Countries Amid Surge in COVID-19 Cases

- On July 30, 2021, the Estonian foreign ministry-imposed Quarantine measures on 13 European countries amid a surge in COVID-19 cases
- The countries include Portugal, Cyprus, the United Kingdom, Andorra, Spain, the Netherlands, Luxembourg, Greece, Malta, Monaco, Ireland, France, and Denmark
- Travelers from these countries must quarantine for ten days on arrival in Estonia
- Restrictions on freedom of movement apply for those arriving in Estonia from countries where the 14-day COVID-19 incidence rate was higher than 200 per 100,000 inhabitants
- People who have already overcome COVID-19 and those fully vaccinated are released from quarantine
- The 14-day COVID-19 incidence rate in Estonia is 117.9 per 100,000 population
- Government limited indoor gatherings without COVID-19 checks to 50 people
- However, starting from August 9, 2021, the limit will be increased to 100 people
- Proof of vaccination is required, for all those aged 18 and over
- Following restrictions will be imposed starting August 9, 2021
 1. Larger public events (what constitutes an "event" is set out below) and activities must conduct COVID-19 vaccine checks on attendees
 2. Indoor event with fewer than 50 people present, and an outdoor one with fewer than 100 people, can go ahead without checks
 3. Attendance for fully COVID-19-checked events is capped at 6,000 (indoors) and 12,000 (outdoors)
 4. The attendance limit is in this case 6,000 in indoor areas and 12,000 outdoors
 5. Attendees must present proof of vaccination, recent negative test result or recovery from COVID-19 before entry
 6. Organizers are responsible for conducting the checks and for checking the authenticity of the certification provided
 7. Performers and staff members at an event must be checked, as well as spectators
 8. Those who do not present the required documentation will be turned away
 9. The indoor attendance restriction applies to the entire building or territory of indoor environments, so, for instance, an entire theater's premises and not just one indoor auditorium etc

Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
