# Update 73: Ireland - Reports Highest Daily Rise of 1,501 COVID-19 Cases, Raising National Total to 299,549

- On July 30, 2021, Ireland reported a record daily high in COVID-19 infections with 1,501 cases, the biggest spike since February 2021
- 169 people were hospitalized with COVID-19, out of which 23 are in intensive care units (ICU)
- Deputy Chief Medical Officer Dr Ronan Glynn, stated that the counties with the highest 14-day incidence rate are Donegal at 954 per 100,000 people, Louth (633), Galway (516), Laois (496) and Monaghan (443)
- The country continues with surge in Delta COVID-19 variant
- Four out of the top ten local hotspots for COVID-19 in the country are all in one county as the incidence rate of the virus
  continues to rise nationwide
- The national average stands at 344 cases per 100,000 people, but some local electoral areas are reporting rates eight times
- The highest incidence rate is Carndonagh in Co Donegal at 2,800 per 100,000 people
- Every 36 people in Co Donegal has tested positive for COVID-19 in the past two weeks
- Buncrana in Co Donegal has the second-highest incidence rate with 1,476 per 100,000
- This is followed by Galway City Central (1,034), Westport (958) and Donegal (955)
- Making up the top ten local hotspots for the virus are Ardee (908), Dundalk South (690), Lifford-Stranorlar (679), Dundalk-Carlingford (668), and Galway City East (639)
- 21 local electoral areas have recorded an incidence rate above 500 over the past fortnight
- County Donegal is a largely Irish-speaking region bordering the Atlantic Ocean in northwestern Ireland
- Reported COVID-19 stats for Ireland:
  - 1. Confirmed Cases: 299.549
  - 2. Deaths: 5,035 (1.68%)
  - 3. Recoveries: 262,338 (87.58%)
  - 4. Vaccine Doses Administered: 5,726,222
  - 5. Fully Vaccinated: 2,686,260 (54.6%)

# Impact level Definitions

Impact Level	Definitions
Immediate	Certain - Supply Wisdom recommends considering prompt action. Examples of Immediate level alert events may include bankruptcy filings, data breaches, unexpected curfews, strikes, power black-outs, major geo-political events etc.
High	Highly likely to occur in the near term (within 3 months) - Supply Wisdom recommends being in a state of readiness to take quick action. Examples of High level alert events may include withdrawal of rating by ratings agencies, hostile takeover, multiple cyber-attacks, new business policies causing significant hardship etc.
Medium	Likely to occur in the mid-term (within 3 to 6 months) - Supply Wisdom recommends reviewing current mitigation steps and being ready to take proactive actions if and when situation deteriorates further. Examples of Medium level alert events may include unplanned C-level exits, suppliers caught in bribery cases, economy slipping into recession.
Low	Possible in the long-term (after 6 months) - Supply Wisdom recommends taking proactive action if situation does not resolve. Examples of Low level alert events may include lawsuits filed against suppliers, client losses, air pollution alerts issued by country's local authorities, unexpected holidays announced for the location etc.
Informational	The event is pertinent information but does not have a risk element associated with it. Examples of Info level alert events may include launch of new solutions, partnerships signed, industry outlook, positive changes in government policies, announcements regarding launch of software parks/ free trade zones/special economic zones etc.
